6 management period, 2000 to 2010.

7 My name is Alejandro Barcenas and I am the
8 area director for the Santa Cruz Active Management Area and
9 I'm the hearing officer at this hearing.

10 The proposed modifications are for the purpose
11 modifying the Non-Per Capita Conservation Program in the
12 municipal conservation program of the Third Management Plan as
13 required by the legislation enacted in 2007, specifically
14 SB 1557. The Director of Water Resources promulgated the
15 proposed modifications by an order entered on January 9, 2008.

16 Notice of the time and place of this hearing
17 was published in Nogales International newspaper on February 5
18 and 12 of 2008. Written notice of the time and place of the
19 hearing was also sent by first-class mail to all municipal
20 providers in the Santa Cruz AMA on February 1, 2008. All
21 notices stated that the hearing will be held at this location
22 beginning at 10:00 on this date.

23 Let the record reflect at this time 10:02 and
24 no one from the public is present at this hearing. There
25 being no one from the public present, the hearing is

1 adjourned. Thank you.
