2 WHEREAS, The Santa Fe Pacific Railroad Company is the owner of the land hereinafter specifically described,
3 included within the limits of the Moqui Indian Reservation, in the Territory of Arizona, and

4 WHEREAS, The Santa Fe Pacific Railroad Company has agreed to relinquish said lands to the United States of
5 America, and to select in lieu thereof vacant nonmineral, non timbered, surveyed public lands of equal area and value and
6 situate in the same Territory, as provided for by the Act of Congress approved April 21, 1904 (33 Stat., 211):

7 NOW, THEREFORE, The Santa Fe Pacific Railroad Company, does hereby release, remise, quitclaim, convey and
8 relinquish to the United States of America, the following described lands, to wit:

9 GILA AND SALT RIVER MERIDIAN -- ARIZONA.

10 Township Twenty-eight North of Range Thirteen East:
11 All of section one containing six hundred and forty acres; all of section
12 three containing six hundred and forty acres; all of section five
13 containing six hundred and forty acres; East half, and the East half
14 of the West half of section seven containing four hundred and eighty
15 acres; all of section nine containing six hundred and forty acres; all
16 of section eleven containing six hundred and forty acres; all of section
17 thirteen containing six hundred and forty acres; all of section
18 fifteen containing six hundred and forty acres; all of section seven-
19 teen containing six hundred and forty acres; East half, and the East
20 half of the West half of section nineteen containing four hundred and
21 eighty acres; Northwest quarter of the Northeast quarter, and the
22 North half of the Northwest quarter of section twenty-one containing
23 one hundred and twenty acres:

24 Township Twenty-nine North of Range Thirteen East:
25 The Southwest quarter of the Southwest quarter of section twenty-nine
26 containing forty acres; East half, and the East half of the West half
27 of section thirty-one containing four hundred and eighty acres; all
28 of section thirty-three containing six hundred and forty acres; and all
29 of section thirty-five containing six hundred and forty acres,

30 situated in Coponino County Territory of Arizona, and containing eight thou-
31 sand

32 acres, and in lieu thereof agrees to select as aforesaid, vacant, nonmineral, non timbered, surveyed public lands, of equal
33 area and value and situate in the same Territory, as provided for by the Act of Congress approved April 21, 1904
34 (33 Stat., 211).

35 IN WITNESS WHEREOF, The said Santa Fe Pacific Railroad Company has caused this deed to be signed by its
36 President and attested by its Assistant Secretary, and sealed with the corporate seal of said corporation, this 10th
37 day of November, 1911, in accordance with and pursuant to a resolution passed by the Board of Directors
38 of said Company on June 5, 1907, a certified copy of which resolution was duly filed with the Commissioner of the Gen-
39 eral Land Office April 17, 1908, and a true copy of which is hereto attached.
