5 America, and to select in lieu thereof vacant nonmineral, nontimbered, surveyed public lands of equal area and value, and
6 situate in the same Territory; as provided for by the Act of Congress approved April 21, 1904 (33 Stat., 211):
7 NOW, THEREFORE, The Santa Fe Pacific Railroad Company, does hereby release, remise, quitclaim, convey and
8 relinquish to the United States of America, the following described lands, to wit:


