6 situate in the same Territory, as provided for by the Act of Congress approved April 21, 1904 (33 Stat., 211):

7 NOW, THEREFORE, The Santa Fe Pacific Railroad Company, does hereby release, remise, quitclaim, convey and
8 relinquish to the United States of America, the following described lands, to wit:

9 GILA AND SALT RIVER MERIDIAN -- ARIZONA.

10 Township Twenty-six North of Range Sixteen East:

11 All of section one containing six hundred and forty acres; all of section
12 three containing six hundred and forty acres; all of section five
13 containing six hundred and forty acres; all of section seven containing
14 six hundred and forty acres; all of section nine containing six hundred
15 and forty acres; all of section eleven containing six hundred and forty
16 acres; all of section thirteen containing six hundred and forty acres;
17 all of section fifteen containing six hundred and forty acres; all of
18 section seventeen containing six hundred and forty acres; and the North
19 east quarter of section nineteen containing one hundred and sixty acres.

20 Township Twenty-seven North of Range Sixteen East:

21 The Southeast quarter of section thirty-three containing one hundred
