

QUIT-CLAIM DEED

THIS INDENTURE, Made the 27th day of March, 1951, between Hubert Tatum, a married man, Grantor and Nell Harris Tatum, his wife, Grantee,

WITNESSETH: That the said grantor, for and in consideration of the sum of One and no/100 Dollars to him in hand paid by the said grantee, the receipt whereof is hereby confessed and acknowledged, has released and quit-claimed, and by these presents does release and quit-claim unto the said grantee, and to her heirs and assigns forever, all the right, title, interest, claim and demand which the said grantor has; in and to the following described property situated in the Counties of Navajo and Coconino, and State of Arizona, to-wit:

North half ($N\frac{1}{2}$) Northeast Quarter ($N.E.\frac{1}{4}$);
 North half ($N\frac{1}{2}$) Southeast Quarter ($S.E.\frac{1}{4}$) of
 the Northeast Quarter ($N.E.\frac{1}{4}$);
 Southwest Quarter ($S.W.\frac{1}{4}$) Southeast Quarter ($S.E.\frac{1}{4}$)
 of the Northeast Quarter ($N.E.\frac{1}{4}$);
 Southwest Quarter ($S.W.\frac{1}{4}$) of the Northeast Quarter ($N.E.\frac{1}{4}$);
 West Half ($W.\frac{1}{2}$) Northwest Quarter ($N.W.\frac{1}{4}$) of the
 Southeast Quarter ($S.E.\frac{1}{4}$);
 Northwest Quarter ($N.W.\frac{1}{4}$) Southwest Quarter ($S.W.\frac{1}{4}$)
 of the Southeast Quarter ($S.E.\frac{1}{4}$) and the West One-half
 ($W\frac{1}{2}$) of Section Twenty-seven (27) except that portion of
 said West One-half south of a barbed wire fence commen-
 cing at the Southwest ($S.W.$) corner of said Section 27
 and extending Northeast to the Southwest ($S.W.$) corner
 of the Northwest One Quarter ($N.W.\frac{1}{4}$) of the Southwest
 Quarter ($S.W.\frac{1}{4}$) of the Southeast Quarter ($S.E.\frac{1}{4}$) of said
 Section 27, containing Four Hundred Eighty-five (485)
 acres, more or less, all the foregoing being in Section
 Twenty-seven (27), Township Nineteen (19) North, Range
 Fifteen (15) East, G & S R B & M, Navajo County, Arizona.

All of Section Twenty-eight (28), Township Nineteen (19)
 North, Range Fifteen (15) East, G & S R B & M, Navajo
 and Coconino Counties, Arizona.

East Half ($E\frac{1}{2}$) Northeast Quarter ($N.E.\frac{1}{4}$);
 Northwest Quarter ($N.W.\frac{1}{4}$) and the
 South Half ($S\frac{1}{2}$) of Section Twenty-one (21), Township
 Nineteen (19) North, Range Fifteen (15) East, G & S R B
 & M, Coconino County, Arizona.

 Thousand Six Hundred Eighty-five (1685) acres, more or
