NOTICE DIRECTED TO EACH PERSON WHO WAS EARLIER SERVED WITH HOPI
TRIBAL NOTICE OF DETERMINATION OF HARMFUL PRESENCE ON THE HOPI
RESERVATION AND ORDER OF EXPULSION AND EXCLUSION, AND WHO HAS NOT
YET MOVED FROM THE HOPI RESERVATION:

"THE HOPI TRIBAL COUNCIL HAS BY RESOLUTION NO. 30 OF DECEMBER 29,
1965, DETERMINED THAT THE PRESENCE OF YOU AND YOUR FAMILY ON THE
HOPI INDIAN RESERVATION IS IN VIOLATION OF THE COUNCIL'S
ORDINANCE NO. 13, AND HAS GIVEN YOU PROPER AND TIMELY NOTICE THAT
UNLESS YOU VOLUNTARILY MOVED FROM THE RESERVATION BY APRIL 1, 1966
YOU WOULD BE REMOVED AND EXCLUDED THEREFROM.

"THE SECRETARY OF THE INTERIOR HAS DETERMINED THAT THE ORDINANCE,
RESOLUTION AND NOTICE WERE PROPER AND WITHIN THE AUTHORITY OF THE
HOPI TRIBAL COUNCIL, AND THAT IT IS HIS DUTY TO ASSIST THE TRIBE
IN THE ENFORCEMENT THEREOF.
