The parties may stipulate to a continuance, which shall be filed no later than seventy-two hours prior to the scheduled hearing. Pursuant to R12-5-2305, a party may request a continuance of the hearing by filing an application with the Clerk of the Board and serving all parties no later than ten days before the date of the hearing. The Chairperson may shorten this time for good cause. The application must state why the continuance is requested, why a stipulation from all other parties was not obtained, and the length of the continuance requested. Any opposing party may, within five days after such service, file and serve a response. The requesting party may file a reply.

Please submit EIGHT(8) copies of all documents (e.g., memoranda, briefs, exhibits, and appraisals) that you intend to submit to the Board at the hearing by August 29, 1997. If you do not submit the materials in advance, the Board may refuse to consider them unless it determines that there was good cause for the failure to submit them on time, and that allowing late materials would be fair and just.
