

- B. Technical Capability: If the person(s) principally responsible for overseeing the operations will change as a result of the conveyance, the applicant must demonstrate that the new permittee is technically capable of operating and reporting for the USF in accordance with all terms and conditions of the USF permit. The applicant must submit the information on technical capability described in Section III.D.1 of the Underground Storage Facility Application Guide as it applies to the new permittee. **See Attachment A.**
- C. Financial Capability: The applicant must demonstrate that the new permittee has the financial capability to construct, operate and report for the USF in accordance with all terms and conditions of the USF permit. The applicant must submit information on financial capability described in Section III.D.2 of the **See Attachment B1 and B2.**

Underground Storage Facility Application Guide as it applies to the permittee. Except that if the facility is already operating, the applicant must submit information based on actual operational costs of the facility.
