



I/we strongly and respectfully object to any encroachment, infringement, and or restriction to our access to water, from the little Colorado river system.

We use our water for Subsistence Farming, Animal Husbandry and Domestic use. Our property is located at: 2226 Prairie Dog Way in Antelope Valley, 40 Acres in the SW $\frac{1}{4}$, SW $\frac{1}{4}$, SW $\frac{1}{4}$, Section 3, Township 14 N, Range 17 E, Assessor Book #201 Map # 35 Parcel #006 as in title for Dennis and Sande Wagner.

We have filed for and recieved confirmation from the Arizona Department of Water Resources, water rights for the above described property, on 11/3/2015 to include Domestic and irrigation rights as described by law, Means of Diversion Well registration # 55-916580. Our Claims to water are only to include the above described property, and nothing beyond its boundaries.

We only object to the restriction of water use on this property and in no way take claim to water outside said boudries. Only to preserve in perpetuity, the right to water with in our legal boundaries with title held by us.
