As technical advisor to the superior court, the Arizona Department of Water Resources ("ADWR") reviewed the 1991 San Pedro River hydrographic survey report ("San Pedro HSR") to determine the accuracy of the legal descriptions presented in

1 Appendix B to the Special Master's Order dated June 17, 2016 (revised August 5, 2016).
2 By reviewing the mapped locations depicted in volume 9 of the San Pedro HSR, ADWR
3 determined that there were typographic errors in five of the legal descriptions found in the
4 watershed file reports contained in volumes 3-6, which also were included in Appendix B.
5 ADWR believes that the legal descriptions listed in Appendix B should be revised as
6 stated in the attached table.
