DESCRIPTIVE SUMMARY: The Arizona Department of Water Resources ("ADWR") provides notice of a new date for filing a report regarding its demonstration project concerning *de minimis* uses and cone of depression tests.

DATE OF FILING: January 6, 2017.

On July 11, 2016, ADWR filed a progress report describing a proposed demonstration project for cone of depression tests for wells located outside the subflow

1 zone in the San Pedro River watershed and for application of Geographic Information
2 System ("GIS") techniques to create abstracts of water rights for *de minimis* uses in the
3 San Pedro River watershed that are not part of the *Sands Group of Cases* (Contested Case
4 No. W1-11-19). At the time, ADWR anticipated completion of the demonstration project
5 and associated report by December 31, 2016. Due to unforeseen circumstances, ADWR
6 was unable to file the demonstration project report by that date. The new date for filing
7 the demonstration project report is January 27, 2017.
