DESCRIPTIVE SUMMARY: This notice of errata is being filed to correct one of the figures in the Demonstration Project Report Concerning *De Minimis* Uses and Cone of Depression Tests.

On January 27, 2017, the Arizona Department of Water Resources ("ADWR") filed its Demonstration Project Report, which presents methodologies for implementing

1 court-ordered procedures for the summary adjudication of *de minimis* uses, and deploying
2 cone of depression tests. The report includes several figures.

3 Figure 3-2 consists of both an upper figure and a lower figure depicting distances
4 between a selected well to certain boundaries. The upper figure is complete and includes
5 the correct distances between the well and the boundaries. The lower figure omits several
6 vertical boundary lines and, due to a typographical error, incorrectly lists the distance
7 between the impermeable boundary and the well.

8 Attached to this notice is a corrected version of Figure 3-2. The corrected version
9 also is being included in the Demonstration Project Report that has been posted on
10 ADWR's web page.
