1 **I. Introduction**

2 This Third Supplemental Disclosure Statement is made on behalf of the Salt River
3 Project Agricultural Improvement and Power District and the Salt River Valley Water Users'
4 Association (collectively, "SRP"). SRP's Third Supplemental Disclosure Statement is
5 provided pursuant to Rule 26.1 of the Arizona Rules of Civil Procedure and the Special
6 Master's Order dated January 18, 2017 (the "Order"). In the Order, the Special Master
7 directed that the parties shall file a final supplemental Rule 26.1 Disclosure Statement for the
8 sole purpose of ensuring that each party has formally disclosed the existence, location,
9 custodian, and general description of any tangible evidence, documents, or electronically
10 stored information that the disclosing party plans to use at trial, including any impeachment
11 materials.

12 The information and positions set forth in this Third Supplemental Disclosure
13 Statement are based on materials disclosed by the United States and other parties to date. The
14 information and positions are subject to change pending SRP's review of documents disclosed
15 by the United States and other parties in their Supplemental Disclosure Statements.

16 With these reservations, and consistent with the requirements of Rule 26.1 of the
17 Arizona Rules of Civil Procedure and the Order, SRP's disclosures relevant to the two issues
18 for adjudication in Phase II of this contested case are set forth below. This disclosure includes
19 only those subsections that contain additional information beyond what already has been
20 disclosed in SRP's previous disclosure statements.


21 **II. Rule 26.1(a)(7): The Existence, Location, Custodian, and General Description of**
