19 hereby requests an extension of time until March 8, 2019 to file its Preliminary  
20 Hydrographic Survey Report as requested by the Court in the December 28, 2016 Order.

24 In the Order dated December 28, 2016, the Special Master requested ADWR to file  
25 its Preliminary Hydrographic Survey Report for the Navajo Reservation by January 7,  
26 2019. ADWR hereby requests an extension of time until March 8, 2019 to file its report.

1 This extension of time is necessary due to the Department's current work load and limited  
2 resources.

3 ADWR believes that if the Court grants this extension, the remaining schedule for  
4 ADWR's analysis of the claims for historic, present and future stockponds, stock  
5 watering, wildlife, and DCMI water uses will be adjusted as follows:

6 ADWR will issue a Preliminary HSR: March 8, 2019


7 Comment Period on Preliminary HSR concludes: June 6, 2019


