Pursuant to the Special Master's Case Management Order filed February 13, 2018, ADWR filed a Meeting Report on April 2, 2018 that addressed the results of a March 26, 2018 meeting between ADWR, the claimants and objectors in this matter. Also, on April 2, 2018, ADWR filed a Meeting Report that addressed the results of another March 26, 2018 meeting between ADWR, the claimants and objectors in contested case W1-11-3317 (*In re Lester Young*). The lands involved in this contested case and the *Lester Young* case were originally homesteaded by William Row. In both cases, counsel for the San Carlos Apache Tribe and the Tonto Apache Tribe ("Tribes") raised an issue concerning whether there was a complete chain of title from the original landowner to the current landowner.

By emails dated April 23, 2018, Harold Young (a claimant in this case) provided ADWR with chain of title information and 25 photographs of the subject land to establish proof of irrigation. Thereafter, ADWR forwarded the documents provided by Mr. Young to the objectors in this case and in the *Lester Young* case with a request to contact ADWR by May 4, 2018 regarding whether a follow-up meeting would be necessary. ADWR received only one response. By email dated May 3, 2018, counsel for the Salt River Project ("SRP") indicated that the additional information did not change SRP's position in these two contested cases. SRP is willing to stipulate for settlement purposes to ownership and irrigation on the subject lands.

Recently, counsel for the Tribes raised the chain of title issue in contested case W1-11-3318 (*In re Bowers*), which also involved land originally homesteaded by William Row. ADWR met with the claimants and objectors in the *Bowers* case on May 1, 2018, and counsel for Gila River Indian Community ("GRIC") indicated that the GRIC agreed with the position taken by the Tribes. After the May 1, 2018 meeting, on May 3, 2018, counsel for the Tribes filed a statement of position regarding the chain of title pursuant to Order filed by the Special Master on April 12, 2018. No other objector filed a statement

of position after the meeting with ADWR on that issue or any other issue. ADWR filed a 1 2 Meeting Report on May 8, 2018 in which ADWR requested that the objectors identify, 3 within 30 days of the date of the report (June 7, 2018), any additional data that they 4 believe would be necessary to resolve the issues in the case. 5 ADWR believes that until the chain of title issue is resolved in this contested case, 6 settlement does not appear to be possible.
