NOTICE IS HEREBY GIVEN that the Arizona Department of Water Resources, as technical advisor to the court, is publishing the Final Hydrographic Survey Report for the Hopi Indian Reservation (Final Hopi HSR) on this 18th day of December, 2015. Objections may be filed by no later than **June 15, 2016**.

Final Hopi HSR

The purpose of the Final Hopi HSR is to describe and analyze the water right claims filed by the Hopi Tribe and the United States (on behalf of the Hopi Tribe) for the Hopi Indian Reservation. 
5 The enclosed Objection Booklet contains detailed information concerning the


