**Certificate Holder:**

The Director of the Department of Water Resources is pleased to forward the enclosed Certificates of Water Right for your records. A certificate is evidence of your right to use a given amount of public waters of the State for a certain beneficial use at the specified location. You may wish to record the certificates with your County Recorder for the county in which the water rights are located. A copy of each water right certificate is maintained in the official records of the Department.

Please note that the right to the use of water as evidenced by a certificate is not absolute; the basis, measure, and limit of any water right granted under provisions of the Public Water Code is the amount actually put to the stated beneficial use, but never more than the amount stated in the certificate. In addition, your water right is given a date of priority, the filing date of the original application, as a means of ranking the water right in relation to all other water rights within a specific watershed. Your water right is subject to prior-vested water rights. For purposes of management of the available water resource in times of scarcity, water rights senior in time to your water right could have "first call" on the available supply of public water; senior water rights could prohibit your use of the water resource until their water rights are satisfied.

The watershed in which your water right is located is undergoing a Superior Court judicial proceeding. This proceeding, called a "water rights adjudication," is a quantification and ranking of all water rights located within the watershed. To participate in the adjudication, you must file a claim with the superior court. If you have not yet taken action to join the court proceedings, you may wish to do so to protect your water right.

Questions concerning the nature of your water rights may be addressed to the Surface Water Sub-unit. Questions concerning the water rights adjudication proceedings may be addressed to the Department's Adjudication Division. The Department cannot give legal advice. If you are concerned about how the adjudication will affect your rights, you may wish to consult an attorney experienced in water rights matters.


**This is to Certify**, that the Arizona Chapter of the Nature Conservancy, Tucson, Arizona, has made proof to the satisfaction of the Arizona Department of Water Resources of a right to the use of the waters flowing in Aravaipa Creek, a tributary of the San Pedro River, for recreation and wildlife, including fish, under Application and Permit Nos. 33-95771.0000. The right to the use of these waters was perfected in accordance with the laws of Arizona, and made and entered of record in the Records of the Department of Water Resources, Phoenix, Arizona, under Certificate No. 95771.0000; that the priority of the right confirmed is October 31, 1990; that the amount of water to which such right is entitled and confirmed, for the purposes previously stated, is limited to an amount actually beneficially used for these purposes, and shall not exceed an amount, as listed below, expressed as specific monthly flow rates and cumulative annual total as measured at the United States Geological Survey streamflow gage #9473000, located on Aravaipa Creek at the Northwest quarter (NW¼), Section 9, Township 7 South, near Mammoth,, Arizona. The specified flow rates (cubic-feet/second) measured at the gage site, expressed as a continuous monthly flow, are as follows:

**A description of the lands for this right, and to which the water is confirmed appurtenant to and put to beneficial use, is as follows:** The beneficial use will occur instream along the meandering course of Aravaipa Creek, the instream use will begin at a point within the Northwest quarter of the Northwest quarter (NW¼NW¼), Section 3, Township 7 South, Range 17 East, continuing downstream to the ending point located within the Southwest quarter of the Northeast quarter (SW¼NE¼), Section 4, Township 7 South, Range 17 East, Gila and Salt River Base and Meridian, Pinal County, Arizona.

**The right to the use of water confirmed is restricted to the places of use previously described.** Water will not be diverted from the natural channel. There shall be no impoundments of public water, nor interference with the natural flow of Aravaipa Creek. There shall be no consumptive use of public waters or degradation of water quality, other than is caused by natural habitat (flora and fauna). There shall be no interference with nor detrimental effect upon prior vested water rights.



**Introduction**

Found in southeast Arizona is Aravaipa Creek, a perennial stream, tributary to the San Pedro River. For 17 miles the waters flow freely through a remote and scenic environment. The Aravaipa watershed extends over 541 square miles and crosses the boundaries of two counties, Pinal and Graham. Precipitation averages 16 inches annually.

The BLM and the TANC, among other environmental groups, have sought to preserve the Aravaipa Canyon and its environment. Numerous studies have been conducted and extensive data has been collected. Each study has provided a better understanding of the canyon's ecosystem.

The BLM began collecting stream flow data in the 1970s, continuing the effort to present. This

information has helped in the preparation of technical reports and support the BLM's claim of instream flows. Initially, the BLM installed and operated their permanent gage stations, collecting instreamflow data on a continuous basis. Due to numerous floods and the subsequent damage to the gages these streamflow monitor efforts were abandoned. Instead of maintaining and repairing gage stations, the BLM and TANC teamed efforts around 1989 to collect bi-monthly instantaneous streamflow data.

TANC has been collecting instantaneous streamflow data since the early 1980s at four monitor locations along the creek. Two monitor locations are located at the boundaries of the BLM's Aravaipa Wilderness area, one at the upstream end and the other at the downstream end. An additional monitor site is located upstream of the canyon proper, at the "old school house site." The fourth site incorporates the extensive streamflow measurements collected at the USGS stream gage station (#09473000) found on lower Aravaipa Creek, below the BLM wilderness. Interpretation of this data has proven very useful in establishing the current and historic streamflow characterization of Aravaipa Creek.

TANC has determined the median flows for each of the four measurement locations and has presented the results in support of the request for issuance of a CWR for each location. Attached is a flow summary sheet prepared by ADWR that compares requested, permitted, and median flows. All flows requested are less than the median flows available and fall within the optimal range of flows needed to support the existing fisheries.

### Water Dependent Resources

#### **Wildlife including Fish:**

The applicants have previously provided information on Aravaipa Creek that identifies seven different species of fish, this includes the spinedace, Loach minnow, Sonoran sucker, roundtail chub, mountain sucker, longfin dace, and the speckled dace. Additional wildlife found along the creeks reaches account for 8 species of amphibian, 47 reptiles, 237 birds, and 46 different mammals.

Information has been provided by the applicants that defined the surface water needs of wildlife (specifically fish). An IFIM model was developed to evaluate the flow needs of Aravaipa's native fisheries, and in turn support the application for an instream flow appropriation. Stream transects were established at points along the reaches.

Data collected, interpreted, and evaluated at the transects included: determination of discharge; development of the streambed profile; areal distribution of depth, velocity, and substrate; water surface elevation; determination of river gradient; and the documentation (such as species variability) of other microhabitat features. Suitability Index (SI) Curves and the Weighted Useable Areas (WUA) versus Discharge relationships were evaluated. Attached are some of the optimum flow curves for specific species of fish found within the creek.

**Recreation:**

The presence of a perennial stream in a desert setting attracts people from all over Arizona, as well as the world (BLM, 1980). Heavy visitor activities include backpacking, photography, birding, swimming, among other interests according to a use survey conducted over a 12 month period in 1987-88, by the BLM. The survey also revealed that 51% of those that had visited the creek before have returned.

The applicants state that the presence of visibly flowing surface water is the dominant driving force for visitor attendance. Any diminishment in the surface flow would in turn reduce the amount of recreational usage.

**Surface Water Flow**

The waters of Aravaipa Creek, within the canyon, as well as near its entrance and exit are perennial. Farther upstream and downstream of the canyon proper, the creek trends from intermittent to ephemeral. Gage data recorded by the USGS since 1966 illustrate the dependability and availability of flow associated with the canyon. The median flows calculated range from 10 to 40 cfs, averaging 20 to 25 cfs.

**Discussion and Miscellaneous Notes:**

1. Recreation throughout the Aravaipa canyon and creek area continues to be a dominant use to date.
2. Optimum flows for fish appear to be consistently near about 10 to 20 cfs.
3. Instream flows available are consistently higher than those flows permitted or requested for certification.
4. Flows requested by the BLM differs from that of the TANC at the same monitor points, upstream and downstream boundaries of the wilderness area. This happened because the ISF permit of the BLM was issued before those of the TANC by three years. The methods of measurements and monitor locations between the BLM and the TANC were initially different, until around 1989 when the stream monitoring became a collaborative effort between both parties. It is suggested that the BLM certificated annual total should not exceed the value permitted: 10,840 AFA.
5. Three of TANC's permitted ISF annual totals, not monthly values, were issued in error. This appears to be due to simple math errors. The annual values to be Certificated should be as follows:

6. The special conditions of each of TANC's ISF permits have been adequately met.
7. The special conditions of the BLM's permit have not been completely met. This is due to the abandonment of the east and west gage sites as they were prone to extensive damage from floods. However, flow data was consistently being collected via use of a flow meter every two weeks or so.

**Recommendations:**

1. Issue CWRs for the four Nature Conservancy ISF applications.
2. Issue CWR for the BLM ISF application.

The Bureau of Land Management applied for an ISF permit on the reach of Aravaipa Creek that run through the wilderness area June 1, 1981. In 1989 an ISF permit was issued to the BLM. Associated with the permit were specific conditions that were to be complied with before the permit could proceed to a certificate. They are as follows:

**General conditions of ISF permit:**

1. There shall be no impoundments of the water of Aravaipa Creek nor interference within the natural flow of Aravaipa Creek.
2. There shall be no consumptive use of public waters other than is caused by natural habitat (flora and fauna).
3. There shall be no interference with nor detrimental effect upon vested water rights.
4. Water shall not be diverted from the natural channel.

**Specific conditions of ISF permit:**

The following must be completed not earlier than July 1, 1994 nor later than July 1, 1995.

- commencing immediately the Permittee shall:

1. maintain a record of instream use
2. measure the flow at the East Aravaipa gauging station where Aravaipa Creek enters the Aravaipa Wilderness Area
3. a minimum of two flow measurements shall be taken each month
4. routine gauging station maintenance shall be performed weekly.
5. a record of the instream flows shall be submitted to the Department.



Please note the enclosed the Proof of Appropriation and Affidavit of Appropriator forms associated with the Arizona Chapter of The Nature Conservancy Permit Nos: 33-95488,33-95489,33-95490 and 33-95771. Data submitted in accord with Permit Nos. 33-95488,33-95489 and 33-95490 include instantaneous streamflow data collected monthly for the last five years at the locations specified in the permits. Summary data presentation and field data sheets are included for each of the three measurement sites for a five year period beginning with the end of the streamflow data collection period presented in the Dr. Hardy justification report submitted to you on October 29, 1990. ## Completing the Proof of Appropriation of Water Form

This is the final report required of a holder of a permit allowing appropriation of public waters. Upon arrival of this report and the receipt of the proper fee the Department shall be ready to issue a Certificate of Water Right.

The Proof of Appropriation of Water is a series of statements of the appropriator, under oath, which are corroborated by the affidavits of two witnesses. This form should be filled in carefully, in a manner that will describe completely the project as actually constructed, giving the number of stock being watered and the quantity of water used under stockwatering permits; giving, in case of irrigation, the number of acres of land actually irrigated and the quantity of water used; and giving the full extent of use under appropriations for whatever other purposes. The practice of merely copying this information from the permit is not proper and should not be followed.

The accompanying affidavits of appropriator and witness must be made before a Notary Public or other officer qualified to administer oaths.



I recently had a conversation with Dr. Don Geldmacher concerning the referenced Permit. Dr. Geldmacher has informed me that because of flood waters down Aravaipa Creek during the early part of 1993, the course of Aravaipa Creek altered onto his private lands within the reach of the stream described in the referenced permit.

I understand from Dr. Geldmacher that he had either given or in some other way conveyed to the Nature Conservancy either holdship or access to his property involved in part in the original reach of Aravaipa Creek as described in the referenced Permit. With this change in course of Aravaipa Creek, it would appear that Nature Conservancy no longer possesses, without interruption, the reach of stream course as described in the Permit; it would appear that the reach is now in two separate parts, intersected by a piece of private property. If this situation is as described by Dr. Geldmacher, there could be some question as to the current validity of the referenced Permit.

I am enclosing a copy of Dr. Geldmacher's recent letter to the Department regarding this matter, as well as a copy of the referenced permit and a copy of a letter Mr. Al Ramsey of this office wrote to Mr. Tom Collazo in November, 1993. I would appreciate your immediate attention to this matter and that you contact Dr. Geldmacher directly and inform me of your conversation and any resulting agreement reached or matters still left to be resolved.

For these reasons I request a review of this permit to appropriate public waters for instream flow # 33-95771. Please advise me of the appropriate form to request this review.



SUBJECT: Hydrologic Review of Instream Flow Application 33-95771, filed by the Nature Conservancy for a Segment of Aravaipa Creek, Pinal County, Az.

**Background**

The Arizona Chapter of the Nature Conservancy filed the referenced application on October 31, 1991 for a 0.75 mile segment of Aravaipa Creek located in Sections 3 and 4, T6S, R17E. The stated beneficial use of the appropriation is for recreation, wildlife, and fish. Requested annual volume is 10,432.38 acre-feet per year distributed on a monthly basis in cubic feet per second of flow as follows:

An Instream Flow Incremental Methodology (IFIM) model was submitted to quantify the streamflow requirements for the native fishes and to justify the requested flow amount. Quantification of streamflow availability was accomplished using daily mean discharge data from the continuous recording U.S.G.S. streamgaging station at Aravaipa Creek near Mammoth, Arizona. This gaging station is approximately one mile downstream from the requested stream reach and has over 20 years of flow data.

**Recommendation**

The Hydrology Division recommends approval of the referenced instream flow application. The applicant has satisfied the minimum technical requirements, adequately assessed the availability of historic streamflow, and quantified the water requirements for fish, wildlife and recreation uses. Requested monthly flow rates do not appear to be excessive for the requested beneficial uses with the exception of June which exceeds the median monthly flow by 2.65 cfs. A permit issued to the applicant should be subject to the following limits and terms.

Upon the request of Mr. Tom Collazo of the Arizona Chapter of the Nature Conservancy, I have reviewed your protests against the referenced applications. Included in the record is a letter from Mr. Collazo to you, dated April 12, 1991. In this letter, Mr. Collazo reiterates that the applications do not involve any impoundments of water nor any interference with the natural flow of Aravaipa Creek. He also states that there will be no consumptive use of the water other than that which is used by the natural habitat, that there will be no degradation of water quality caused by this appropriation, and most importantly to you, that there shall be no interference with vested water rights.



Dear Wilford:

I am writing in response to your letter of February 27, 1991, to the Arizona Department of Water Resources protesting The Nature Conservancy's applications for instream flow water permits for Aravaipa Creek.

On each of the four applications that we submitted to DWR we listed several conditions which did not appear on the posting notices which you may have seen at the Klondyke Post Office and on our property. These conditions are:

- a. There shall be no impoundments of public waters nor interference with the natural flow of Aravaipa Creek.
- b. There shall be no consumptive use of public waters other than caused by the natural habitat (flora and fauna).
- c. There shall be no degradation of water quality by reason of applicant's use of these public waters other than as caused by the natural habitat.
- d. There shall be no interference with nor detrimental effect upon prior vested rights as a result of the requested instream use.

We believe that the last of these conditions addresses the concerns expressed in your letter of protest. If approved, these permits will carry a 1990 priority date, which is junior to the dates listed for your water rights in the DWR's recently published "Preliminary Hydrographic Survey Report for the San Pedro River Watershed." We understand that all water rights are subject to the General Adjudication of the Gila River System, but these instream permits will not affect your adjudicated senior water rights.

Page Two

I hope that this additional information will satisfy your concerns about our applications, and that you will agree to withdraw your protest. Please let me know if you need any further information.

It has come to our attention that the Nature Conservancy has applied for a "water right" on Aravaipa Creek. As a user of the water in Aravaipa canyon, both above and below the head water of the natural flow in the canyon, I have concerns regarding this application. As I use water for irrigation and other incidental uses I would protest any permit to the Nature Conservancy that would change in any way my rights to use. I greatly appreciate your immediate response and attention to this matter. If any further information is needed to substantiate the credence to this protest please contact me.



**GROUNDS FOR PROTEST**

Any ruling which would restrict the present usage of the instream flow of the Aravaipa Creek would be most strenuously objectionable. The concern I have is that the Conservancy wants to eliminate my diversion of Aravaipa Creek water. My Water rights have been established and continuous for over a hundred years, and are essential to economical stability and continued cultivation of the farm, which is essential to the continued operation of the Cattle ranch, which is my sole livelihood.

My predecessors and I have always worked harmoniously within the canyon to protect the creek and the land, and have only taken what was needed.

- The facts are:
1. I have priority upon the water by usage and by filing in accordance with the requirements of State Land Department.
  2. There has been no change in stream flow, nor has my usage changed nor intent to use change since the filing with the state.
  3. Any alteration or restriction on my usage of the stream flow would be counter to the intent and laws of the State of Arizona as I understand them.
  4. To issue such a right to the Nature Conservancy would be counterproductive and punitive to the present water users located within the Arivaipa Canyon environs. I fail to see the benefit to the Public of the State of Arizona that would come from the granting of such a water permit/appropriation.







I am writing in response to your letter of February 27, 1991, to the Arizona Department of Water Resources protesting The Nature Conservancy's applications for instream flow water permits for Aravaipa Creek.

On each of the four applications that we submitted to DWR we listed several conditions which did not appear on the posting notices which you may have seen at the Klondyke Post Office and on our property. These conditions are:

- a. There shall be no impoundments of public waters nor interference with the natural flow of Aravaipa Creek.
- b. There shall be no consumptive use of public waters other than caused by the natural habitat (flora and fauna).
- c. There shall be no degradation of water quality by reason of applicant's use of these public waters other than as caused by the natural habitat.
- d. There shall be no interference with nor detrimental effect upon prior vested rights as a result of the requested instream use.

We believe that the last of these conditions addresses the concerns expressed in your letter of protest. If approved, these permits will carry a 1990 priority date, which is junior to the dates listed for your water rights in the DWR's recently published "Preliminary Hydrographic Survey Report for the San Pedro River Watershed." We understand that all water rights are subject to the General Adjudication of the Gila River System, but these instream permits will not affect your adjudicated senior water rights.



I greatly appreciate your immediate response and attention to this matter. If any further information is needed to substantiate the credence to this protest please contact me.



Please accept for posting the enclosed applications for instream base flow water rights on four segments of Aravaipa Creek that run through or abut property that is part of The Nature Conservancy's Aravaipa Creek Preserve. Two of the segments are upstream from the stream segment in the BLM Wilderness Area, for which instream permit #33-87114 was issued on March 19, 1989, and two are downstream.

The enclosed applications are largely based on the instream habitat needs of the native fish which occupy each of the segments as detailed in the enclosed report by Dr. Thomas B. Hardy. The instream base flows will also be beneficially used for recreation, not only for hikers bound for the BLM Wilderness Area who traverse Conservancy-owned property adjacent to some of the segments or who traverse the stream segments themselves, but also for participants in Conservancy-sponsored field trips on property adjacent to or within each segment. The beneficial use for native fish and recreation within the Conservancy segments as well as the requested base flow amounts, are similar to those permitted to the BLM for the wilderness reach. The base flow will also be beneficial to the riparian vegetation along the Conservancy segments and to a great variety of large and small wildlife.


As indicated in the Hardy report, the amounts sought to be permitted as base flow do not exceed the medians of daily measurements taken during each month of the year, or of correlations from such measurements. The requested amounts therefore necessarily exclude some higher, less frequent flows that may be used beneficially to provide more optimum instream fish habitat, to more fully sustain riparian vegetation, to provide natural flood, scouring or channel maintenance flows, or to provide greater levels of aesthetic appreciation or recreation. The Nature Conservancy may seek water rights for such other instream beneficial uses in subsequent and separate applications with more junior priority dates.


The applications for the Upper East End and Upper West End segments seek to permit flow amounts measured at points upstream from the downstream termini of these reaches. The requested flow amounts therefore exclude any gain from the point of measurement to the downstream termini. If The Nature Conservancy is able to measure or other wise determine the magnitude of the gain, it may seek to increase the base flow water right at the downstream termini of these segments by the amount of such gain, but again in separate and junior applications.

We have attached a check for \$25.00 to each of the applications for the filing fees and USGS quad maps showing each segment and point of measurement. We would very much appreciate your prompt posting of these applications so that any protests can be resolved and the permits considered in the adjudication of the San Pedro River Basin.
