Historic Huachuca Reactivated

Forum Speakers Support Bricker

In order that members could obtain a comprehensive picture of the highly-controversial Bricker amendment to the U. S. Constitution, the regular meeting of Morgan McDermott Post, American Legion, last Wednesday was given over to an open forum on the subject.

Sponsored by Arizonians for the Bricker Amendment, the 200 persons present were urged to support the measure. The Bricker amendment would require that all treaties, executive agreements and United Nations agreements be ratified by both the Senate and House of Representatives. At present, treaties require a two-thirds vote of the Senate only, and executive or UN agreements need not be ratified.

It is feared that constitutional rights will be abridged by international laws if the provision making treaties the supreme law of the land is not curtailed.

Opponents to the Bricker amendment say the President of the U.S. would never agree to any treaty which would infringe upon constitutional rights. If the President has the power to make treaties, there is no safeguard to prevent such treaties from usurping the rights guaranteed by the Constitution. This is where the "checks and balances" as provided by the Constitution should be used.

Selected as Site For Electronics Proving Grounds

Selection of Ft. Huachuca to be used as a permanent super-secret electronics proving ground for the Army was revealed in a joint announcement made by Arizona's congressional delegation.

Fred Stofft, 1953 president of the Tucson Chamber of Commerce, predicts that, "It is only the beginning of an operation that in a year or so may total 15,000 to 20,000 men." In Phoenix Gov. Pyle said, "This is the culmination of a tremendous amount of work on the part of Arizona's entire congressional delegation, state and civic officials.

Transfer of signal corps electronic and aviation activities from Ft. Monmouth to Arizona will be made Feb. 1. The necessity for more space for experimental purposes is now available. Personnel will include about 7,500 service men and 1,000 civilians with a payroll of 9½ million dollars.

The historic Fort was established 78 years ago to quiet Indian raids on the Arizona frontier. It became a permanent military post and at one time included complete Negro units. By 1931 it was one of the most modern military posts in the country and with the threat of World War II trained as many as 30,000 soldiers at one time. In June last year, it was ordered deactivated as a military economy move.

Over 60 million dollars have been spent on Ft. Huachuca. This includes some 15 million preparing it as a training center during World War II and another 15 million for the training of air force engineers during the Korean conflict.

There are 1,156 buildings on the post. They include administration buildings, barracks, detached and semi-detached officers' quarters,
