# LIST OF MUNICIPAL WATER PROVIDERS DESIGNATED AS HAVING AN ASSURED OR ADEQUATE WATER SUPPLY

The list on the reverse side of this page specifies the municipal water providers in the State of Arizona, which are currently designated by the Department of Water Resources as having an assured or adequate water supply. The terms "assured" and "adequate," although somewhat different in their legal implications, mean that sufficient water of suitable quality will be continuously available to meet the anticipated water needs for at least one hundred years.

Please note that assured and adequate water supply designations do not necessarily coincide with a city or town's corporate limits, nor with a private water company's franchised area. Also, since this listing is subject to change at any time, the Department of Water Resources should be contacted to obtain the most up-to-date information regarding the status of a water provider's assured or adequate water supply designation. In order for a new development to make use of a water provider's designation, there must exist a written commitment of service from the water provider. Pursuant to A.R.S. § 45-576, it is the responsibility of the platting entity to review this service agreement as evidence that the platted development will receive service from the designated provider.
