

ATTACHMENT A

I/we object to any possible infringement or restriction on our right to access water for domestic, agricultural, or animal husbandry use from the Coconino Aquifer upon which our 125 acres of properties, designated 201-36-007, 201-36-008, 201-36-001C, and 201-36-002D, rest in "Antelope Valley", Arizona. They are specifically located outside of the Hopi Reservation lands, and we pray the Court to affirm the decision of Judge Ballinger's minute order of November 4, 2004, wherein the Court "Limited the Hopi FSR to Reservation Lands."

This objection does not seek in any way to restrict or inhibit the Hopi, Navajo, or United States litigants' water access or use, but only to preserve in perpetuity our relatively insignificant access and utilization of the deep Coconino Aquifer as specified above.

Our domestic use includes water for several fruit trees and shade trees, vegetable garden, herb garden, vineyard, animals, and poultry. Our well operates with a solar pump and our farm is entirely off the grid. This is a 3-generation family farm and will extend into the future.




