

SUBJECT: Distribution of the McIntire-Stennis Cooperative Forestry
Act Funds for Fiscal Year (FY) 2006

Included in this e-mail transmission is a copy of the CSREES-OD-1088-D, Distribution of McIntire-Stennis Funds for FY 2006. The distribution identifies funds for the Small Business Innovation Research Program, reflecting the requirement that not less than 2.50 percent of the funds be set aside for that purpose in FY 2006, and a set aside for biotechnology risk assessment.

A Planning & Reporting page has been established on our website to assist you in locating the requirements, due dates, and submission information for the McIntire-Stennis Research Program Formula funds and all other Formula funds. The research and extension formulas are organized in groups for the three land-grant types: 1862 land-grant institutions, 1862 land-grant institutions in the U.S. territories, and 1890 land-grant institutions.
