**STIPULATION AND CONSENT ORDER
REVOKING CERTIFICATE OF
ASSURED WATER SUPPLY**

The Department of Water Resources (Department) and DMB White Tank, LLC (DMB) agree as follows:

10

I. JURISDICTION

- 11 1. This Stipulation and Consent Order is entered into pursuant to the authority of the Director
12 of the Department (Director) as set forth in A.R.S. §§ 45-105 and 45-576 and A.A.C. R12-
13 15-709(A).

II. FACTUAL BACKGROUND

- 15 2. Verrado Parcel 4.416 and Verrado Parcel 4.418 are subdivisions located in Maricopa
16 County, Arizona, within the Phoenix Active Management Area.
- 17 3. On September 14, 2006, the Department issued Certificate of Assured Water Supply
18 (Certificate) No. 27-402170.0000 for 21 lots in Verrado Parcel 4.416 with an estimated
19 water demand of 15.21 acre-feet per year to Fidelity National Title Insurance Company, a
20 California corporation, as Trustee of Trust No. B176, with Caterpillar Foundation, an
21 Illinois not-for-profit corporation, as first beneficiary and DMB, an Arizona limited liability
22 company, as second beneficiary. Physical availability for Certificate No. 27-402170.0000
23 was demonstrated with Analysis of Assured Water Supply No. 28-400460 as extended by
24 42-400460.0001 and 42-400460.0002 (Verrado Analysis).

- 1 4. On September 14, 2006, the Department issued Certificate No. 27-402172.0000 for 36 lots
2 in Verrado Parcel 4.418 with an estimated water demand of 18.44 acre-feet per year to
3 Fidelity National Title Insurance Company, a California corporation, as Trustee of Trust
4 No. B176, with Caterpillar Foundation, an Illinois not-for-profit corporation as first
5 beneficiary and DMB, an Arizona limited liability company as second beneficiary. Physical
6 availability for Certificate No. 27-402172.0000 was demonstrated with the Verrado
7 Analysis.
8
- 9 5. Prior to the issuance of Certificate Nos. 27-402170.0000 and 27-402172.0000, Verrado
10 Parcels 4.416 and 4.418 were enrolled as member lands in the Central Arizona Groundwater
11 Replenishment District (CAGR), pursuant to A.R.S. § 48-3774.
12
- 13 6. On December 1, 2015, DMB submitted a request to CAGR to terminate its member land
14 status for Verrado Parcels 4.416 and 4.418.
15
- 16 7. The CAGR has verified that DMB is the current owner of all the lands contained within
17 Certificate Nos. 27-402170.0000 and 27-402172.0000.
18
- 19 8. On January 12, 2016, DMB submitted a request for revocation of Certificate Nos. 27-
20 402170.0000 and 27-402172.0000 and a return of the groundwater demand included in the
21 certificates to the Verrado Analysis.

- 23 9. No residential lots have been sold nor has any building begun at Verrado Parcels 4.416 and
24 4.418.

III. EFFECTIVE DATE

10. This Stipulation and the Consent Order below, when signed and approved by the Director or his designated representative, shall have the full force and effect of a final decision and order, and it shall be effective as of that date.

IV. CONSENT TO REVOCATION OF CERTIFICATES

11. DMB waives its right to a hearing in this matter and the right to appeal this Stipulation and the Consent Order below.

12. DMB affirms that it is the sole owner of the lands described in Certificate Nos. 27-402170.0000 and 27-402172.0000.

13. DMB agrees that Certificate No. 27-402170.0000 shall be revoked effective upon CAGR D's termination of member land status for Verrado Parcel 4.416.

14. DMB agrees that Certificate No. 27-402172.0000 shall be revoked effective upon CAGR D's termination of member land status for Verrado Parcel 4.418.

15. DMB admits the jurisdiction of the Department and consents to the revocation of Certificate No. 27-402170.0000 upon termination of member land status for Verrado Parcel 4.416 and consents to entry of the Consent Order below.


16. DMB admits the jurisdiction of the Department and consents to the revocation of Certificate No. 27-402172.0000 upon termination of member land status for Verrado Parcel 4.418 and consents to entry of the Consent Order below.

- 1 17. Upon revocation of Certificate No. 27-402170.0000, 15.21 acre-feet per year of
2 groundwater will be returned to Analysis of Assured Water Supply No. 28-400460 as
3 extended by 42-400460.0001 and 42-400460.0002.
4
- 5 18. Upon revocation of Certificate No. 27-402172.0000, 18.44 acre-feet per year of
6 groundwater will be returned to Analysis of Assured Water Supply No. 28-400460 as
7 extended by 42-400460.0001 and 42-400460.0002.
8
- 9 19. DMB agrees that the return of the groundwater to Analysis of Assured Water Supply No.
10 28-400460 as extended by 42-400460.0001 and 42-400460.0002 shall not extend the term
11 of the analysis.
12
- 13 20. DMB affirms that no promise was made to induce it to enter this Stipulation and declares
14 that it has entered this Stipulation voluntarily.
