**STIPULATION AND CONSENT ORDER
REVOKING CERTIFICATE OF
ASSURED WATER SUPPLY**

The Department of Water Resources (Department) and DMB White Tank, LLC (DMB) agree as follows:

I. JURISDICTION

1. This Stipulation and Consent Order is entered into pursuant to the authority of the Director of the Department (Director) as set forth in A.R.S. §§ 45-105 and 45-576 and A.A.C. R12-15-709(A).

II. FACTUAL BACKGROUND

2. Verrado Parcel 4.401, Verrado Parcel 4.403, Verrado Parcel 4.405, Verrado Parcel 4.406, Verrado Parcel 4.407, Verrado Parcel 4.408, Verrado Parcel 4.414 and Verrado Parcel 4.415 are subdivisions located in Maricopa County, Arizona, within the Phoenix Active Management Area.
3. On September 21, 2006, the Department issued Certificate of Assured Water Supply (Certificate) No. 27-402175.0000 for 20 lots in Verrado Parcel 4.401 with an estimated water demand of 9.15 acre-feet per year to Fidelity National Title Insurance Company, a

Physical availability for Certificate No. 27-402175.0000 was demonstrated with Analysis of Assured Water Supply No. 28-400460.0000 as extended by 42-400460.0001 and 42-400460.0002 (Verrado Analysis).

Physical availability for Certificate No. 27-402179.0000 was demonstrated with the Verrado Analysis.

6. On September 14, 2006, the Department issued Certificate No. 27-402180.0000 for 42 lots in Verrado Parcel 4.406 with an estimated water demand of 15.8 acre-feet per year to

Physical availability for Certificate No. 27-402182.0000 was demonstrated with the Verrado Analysis.

9. On August 22, 2006, the Department issued Certificate No. 27-402168.0000 for 40 lots in Verrado Parcel 4.414 with an estimated water demand of 17.72 acre-feet per year to Fidelity

National Title Insurance Company, a California corporation, as Trustee of Trust No. B176, with Caterpillar Foundation, an Illinois not-for-profit corporation as first beneficiary and DMB, an Arizona limited liability company as second beneficiary. Physical availability for Certificate No. 27-402168.0000 was demonstrated with the Verrado Analysis.

10. On September 14, 2006, the Department issued Certificate No. 27-402169.0000 for 43 lots in Verrado Parcel 4.415 with an estimated water demand of 28.74 acre-feet per year to Fidelity National Title Insurance Company, a California corporation, as Trustee of Trust No. B176, with Caterpillar Foundation, an Illinois not-for-profit corporation as first beneficiary and DMB, an Arizona limited liability company as second beneficiary. Physical availability for Certificate No. 27-402169.0000 was demonstrated with the Verrado Analysis.

11. Prior to the issuance of Certificate Nos. 27-402175.0000, 27-402177.0000, 27-402179.0000, 27-402180.0000, 27-402181.0000, 27-402182.0000, 27-402168.0000, and 27-402169.0000, Verrado Parcels 4.401, 4.403, 4.405, 4.406, 4.407, 4.408, 4.414 and 4.415 were enrolled as member lands in the Central Arizona Groundwater Replenishment District (CAGRDR), pursuant to A.R.S. § 48-3774.

12. On August 29, 2016, DMB submitted a request to CAGRDR to terminate its member land status for Verrado Parcels 4.401, 4.403, 4.405, 4.406, 4.407, 4.408, and 4.415.

13. On September 29, 2016, DMB submitted a request to CAGRDR to terminate its member land status for Verrado Parcel 4.414.

1 14. The CAGR D has verified that DMB is the current owner of all the lands contained within
2 Certificate Nos. 27-402175.000, 27-402177.0000, 27-402179.0000, 27-402180.0000, 27-
3 402181.0000, 27-402182.0000, 27-402168.0000 and 27-402169.0000.

4
5 15. On September 29, 2016, DMB submitted a request for revocation of Certificate Nos. 27-
6 402175.000, 27-402177.0000, 27-402179.0000, 27-402180.0000, 27-402181.0000, 27-
7 402182.0000, 27-402168.0000 and 27-402169.0000 and a return of the groundwater
8 demand included in the certificates to the Verrado Analysis.

10 16. No residential lots have been sold nor has any building begun at Verrado Parcels 4.401,
11 4.403, 4.405, 4.406, 4.407, 4.408, 4.414 and 4.415.

13 **III. EFFECTIVE DATE**

14 17. This Stipulation and the Consent Order below, when signed and approved by the Director
15 or his designated representative, shall have the full force and effect of a final decision and
16 order, and it shall be effective as of that date.

19 18. DMB waives its right to a hearing in this matter and the right to appeal this Stipulation and
20 the Consent Order below.

43. Upon revocation of Certificate No. 27-402169.0000, 28.74 acre-feet per year of groundwater will be returned to Analysis of Assured Water Supply No. 28-400460.0000 as extended by 42-400460.0001 and 42-400460.0002.

44. DMB agrees that the return of the groundwater to Analysis of Assured Water Supply No. 28-400460.0000 as extended by 42-400460.0001 and 42-400460.0002 shall not extend the term of the analysis.

45. DMB affirms that no promise was made to induce it to enter this Stipulation and declares that it has entered this Stipulation voluntarily.


