**I. Order of Adoption**

In accordance with the requirements of A.R.S. § 45-571, Thomas Buschatzke, Director of the Arizona Department of Water Resources (“Director”), hereby adopts the attached document as the management plan for the Tucson Active Management area (“AMA”) for the fourth management period (“Fourth Management Plan”). The Fourth Management Plan contains a preface and the following chapters: Chapter 1 (Introduction), Chapter 2 (Hydrology), Chapter 3 (Water Demands and Supply), Chapter 4 (Agricultural), Chapter 5 (Municipal), Chapter 6 (Industrial), Chapter 7 (Water Quality), Chapter 8 (Underground Water Storage, Savings and Replenishment), Chapter 9 (Water Management Assistance), Chapter 10 (Implementation), Chapter 11 (Projected Budgets), and Chapter 12 (Water Management Strategy).

On May 13, 2016, the Director issued the proposed Fourth Management Plan for the Tucson AMA (“proposed plan”). A public hearing on the proposed plan was held in Tucson, Arizona on June 30, 2016. The comment record remained open for the submission of written comments until June 30, 2016 at 5:00 p.m.

Simultaneously with this order, the Director is filing in the Department of Water Resources (“Department”) a written summary and findings with respect to matters considered during the hearing record period. As a result of additional review by the Director, the Director has made a non-substantive correction of a typographical error, as described below.

1                   **II. Modifications Made to Proposed Fourth Management Plan**

2                   The following modification has been made to the proposed plan:

3                   A. Chapter 6, Industrial

- 4                   1. On Page 6-30, the section reference 6-1603.B.2.c - was modified to correct it. The  
5                   correct reference is 6-1603.A.

6                   **III. Motions for Rehearing or Review**

7                   Pursuant to A.R.S. § 45-571(C), a summary of this order, the management plan adopted  
8 by this order and the Director’s findings with respect to matters considered during the public  
9 hearing will be published once each week for two consecutive weeks in the Arizona Daily Star  
10 newspaper, beginning on Wednesday, August 3, 2016. Pursuant to A.R.S. § 45-114(C), any  
11 person may file a motion for rehearing or review of this order and the management plan adopted  
12 by this order no later than Saturday, September 10, 2016 at 5:00 p.m. Any motion for rehearing  
13 or review must be filed with the Docket Supervisor, Arizona Department of Water Resources,  
14 1110 W. Washington Street, Suite 310, Phoenix, Arizona 85007.

15                   **IV. Judicial Review**

16                   This order shall become final for the purpose of judicial review as follows:

- 17                   1. Pursuant to A.R.S. § 45-114(C), a party is not required to file a motion for rehearing  
18 or review in order to exhaust administrative remedies and may seek judicial review of the Fourth  
19 Management Plan once the director’s decision becomes final.

20                   2. If no person files a motion for rehearing or review within the time allowed by section  
21 III of this order, this order shall become final for the purpose of judicial review on Sunday,  
22 September 11, 2016.

23                   3. If any person files a timely motion for rehearing or review, the Director will issue a  
24 decision on the motion and may modify the management plan after rehearing or review. After  
25 the Director issues decisions on all motions for rehearing or review, the Director will publish  
notice that the management plan is final once each week for two consecutive weeks in the

1 Arizona Daily Star. The notice will include a description of any modifications made after  
2 rehearing or review. The management plan shall be final for the purpose of judicial review when  
3 the notice is published for the second time.

4 IT IS HEREBY ORDERED that the attached document is adopted as the Fourth  
5 Management Plan.
