 - o Special Enhancement Areas (“SEAs”)
 - o What would reward be (extra credits? \$\$?) Would need to store in area of concern, but recover elsewhere.

- Current 50% Cut to Aquifer for Managed Recharge Projects
- 4-foot Decline Criteria for Recovery Wells

- Current incentives exempt remediated groundwater from municipal conservation requirements, and account for remediated groundwater as allowable groundwater under Assured Water Supply Rules. These incentives are currently set for expiration in 2025.
