## INSTRUCTIONS FOR COMPLETING THE SCHEDULE BMP

As a part of water use reporting for your BMP Farm Unit, the BMP farm operator is required to complete a Schedule BMP annually. It updates your BMP Worksheet, which was included as part of your BMP Enrollment Application. The operator files only one Schedule BMP for the entire BMP Farm Unit. Your BMP Farm Unit is made up of the Irrigation Rights listed on this schedule under the heading "Irrigation Rights Within the BMP Farm Unit."

The BMP Farm Operator must complete and sign the Schedule BMP. If the farm is located within an irrigation district that files your Annual Water Withdrawal And Use Report on your behalf, you still must submit the Schedule BMP to ADWR.

As you complete the Schedule BMP, you may wish to consult the definitions of Approved Best Management Practices, Appendix 4B to the Third Management Plan. These definitions were included in your application package. A copy may be found on the ADWR website, [www.azwater.gov](http://www.azwater.gov), by following the "Permits, Forms, and Applications" link, under the heading "Agricultural Best Management Practices - Reports and Forms".
