3 By Minute Entry filed April 7, 2017, the Special Master directed the Arizona
4 Department of Water Resources (“ADWR”) to inform the court whether ADWR
5 previously had reviewed stipulated water right abstracts for certain springs claimed by the
6 United States in the above-referenced contested case. Based on information provided by
7 the United States, the springs in question are: (1) No. 2 Spring (claim no. 39-11201), (2)
8 Upper Boulder Spring (claim no. 39-11202), (3) Claridge Spring (claim no. 39-11203),
9 and (4) Warm Spring (claim no. 39-14445). ADWR confirmed that it previously
10 reviewed the stipulated water right abstracts for each of these four springs, and determined
11 that the information in each of these abstracts was accurate and complete. See ADWR’s
12 report filed July 19, 2016.
