Pursuant to Arizona Revised Statutes ("A.R.S.") § 45-189.01, a person who is entitled to use surface water may include a surface water right or claim in a Water Conservation Plan and file a Water Conservation Plan Notice with the Director of the Arizona Department of Water Resources ("Department"). According to section 45-189.01, if certain requirements are satisfied, the conservation of water pursuant to a properly filed Water Conservation Plan Notice "does not constitute an abandonment or forfeiture of the water conserved." However, "a person may not accrue long-term storage credits for any water that is conserved in a Water Conservation Plan."

A Water Conservation Plan Notice must designate the duration of the Water Conservation Plan for up to ten years. The person filing the Water Conservation Plan Notice "may file a subsequent notice for some or all of the water rights and/or claims before expiration of the designated time and may file subsequent Water Conservation Plan Notices for one or more periods of up to ten years each." The Water Conservation Plan will be posted on the Department's website.

INSTRUCTIONS

The following information is provided to assist in filing a Water Conservation Plan Notice by using the attached form developed by the Department for that purpose. **Please be sure to complete the entire form, sign, date, and mail it to the Department at the address indicated on the form.** A fee is not required to file the form. The Department suggests that you retain a copy of the Water Conservation Plan Notice and any other documents that may be filed with the Director.

Line by line instructions for completing the form and filing a Water Conservation Plan Notice are set forth below. Please provide the following information:

1. Name and address of the person filing the Water Conservation Plan Notice. This person must be entitled to use the surface water right(s) and/or claim(s) included in the Water Conservation Plan.
2. For each surface water right and/or claim included in the Water Conservation Plan, please use Attachment A to provide a description of the surface water right(s) and/or claim(s) included in the Water Conservation Plan. Please file Attachment A with the Water Conservation Plan Notice form.
3. Description of any water conservation measures that will be implemented as part of the Water Conservation Plan (attach any supporting documentation).
4. Designation of duration of the Water Conservation Plan, (up to 10 years). Please note you may file a subsequent Water Conservation Plan before expiration of the designated time and may file subsequent Water Conservation Plan Notices for some or all of the surface water rights and/or claims included in the Water Conservation Plan for one or more periods up to 10 years each.

8. Statement affirming that you hold a valid surface water right that is subject to the Water Conservation Plan and you do not intend to abandon such surface water right during the terms of the Water Conservation Plan by marking "yes" on the form.

Please note that by signing the form, you are affirming and representing that the information contained in the form (including any attachments) is true and accurate to the best of your knowledge and belief at the time of filing.
