

PETITION FOR DESIGNATION OF IRRIGATION NON-EXPANSION AREA IN THE SAN SIMON VALLEY SUB-BASIN

Petition Summary and Background	Irrigation users of groundwater within the boundaries of the San Simon Valley sub-basin are concerned about the long-term sustainability of the sub-basin's groundwater resources and the corresponding viability of the sub-basin's communities and primary economic foundation - agriculture. After careful consideration of the issues and solutions, concerned citizens are advancing this petition seeking designation of an Irrigation Non-expansion Area for the San Simon Valley sub-basin.
Action Petitioned For	We, the undersigned, are concerned citizens comprising not less than one-fourth of the irrigation users of groundwater within the boundaries of the San Simon Valley sub-basin, urge the Director of the Arizona Department of Water Resources to act now to designate the San Simon Valley sub-basin as an Irrigation Non-expansion Area.
Certification	By signing below, I/we certify that I/we "irrigate" and put groundwater to an "irrigation use" in the San Simon Valley sub-basin, which, pursuant to A.R.S. §§ 45-402.18 and 45-402.23, means the use of groundwater water on two or more acres of land to produce plants or parts of plants for sale or human consumption, or for use as feed for livestock, range livestock or poultry, as such terms are defined in A.R.S. § 3-1201.
