

1 In the Minute Entry Order filed March 26, 2019, the Special Master requested that
2 ADWR and BHP Copper jointly file a report on the locations of wells relative to the
3 boundary of the subflow zone by March 31, 2020. ADWR hereby requests an extension
4 of time until July 30, 2020 to file its report. This extension of time is necessary because
5 several of the wells are located in close proximity to the subflow zone boundary;
6 therefore, ADWR must obtain additional GPS equipment and perform additional field
7 work to determine more precise locations of the wells.
