
1 As discussed during the December 11, 2019 status conference in this matter and in
2 the Minute Entry Order filed February 19, 2020, ADWR scheduled a meeting between the
3 parties and experts in this case to discuss progress on the Subflow Depletion Test on
4 March 24, 2020. Many parties and their experts made arrangements to travel to Phoenix
5 for this meeting. After careful consideration of the global spread of COVID-19 for the
6 past several weeks and the mounting evidence that social distancing is the most successful
7 containment strategy, ADWR believes it is necessary to reschedule the meeting. ADWR
8 also believes that it would be infeasible to hold this meeting telephonically. ADWR
9 hereby provides notice that the March 24, 2020 meeting is cancelled. ADWR will
10 monitor the situation over the next thirty (30) days and will provide the Court and parties
11 with an update by April 17, 2020.
