DESCRIPTIVE SUMMARY: The Arizona Department of Water Resources (“ADWR”) provides an update to the Court and parties on rescheduling the subflow depletion meeting between parties and experts.

1 As discussed during the December 11, 2019 status conference in this matter and in
2 the Minute Entry Order filed February 19, 2020, ADWR scheduled a meeting between the
3 parties and experts in this case to discuss progress on the Subflow Depletion Test for
4 March 24, 2020. Due to the global spread of COVID-19, ADWR cancelled the March 24,
5 2020 meeting. ADWR believes that it may be feasible to conduct the meeting virtually
6 with certain parameters in place; therefore, ADWR will reschedule the meeting for
7 Tuesday, June 23, 2020. ADWR will send system requirements and instructions for
8 participating in the meeting to each party directly.


