20 On March 28, 2024 the Arizona Department of Water Resources (“ADWR”) filed
21 a 120-day notice of intent to file the final hydrographic survey report (“HSR”) concerning
22 cultural, tribal, recreational, fish, wildlife, conservation, mining, heavy industrial,
23 commercial, and irrigation water uses (“Phase II” claims) for the portion of the Navajo
24 reservation.

1 Reservation within the Little Colorado River Watershed pursuant to Arizona Revised
2 Statutes (“A.R.S.”) § 45-256 (H) and Pretrial Order No. 6.

3 However, on June 24, 2024 the Court received a *Joint Motion to Postpone Issuance*
4 *of the Final Phase II HSR* (“Joint Motion”)¹, filed on behalf of the Navajo Nation, United
5 States, Hopi Tribe, San Juan Southern Paiute Tribe, Little Colorado River Coalition, Salt
6 River Project Agricultural Improvement and Power District, Arizona State Land
7 Department, City of Flagstaff, Atkinson Trading company, and Arizona Public Service
8 Company (the “Parties”). The Court granted the Joint Motion on June 26, 2024 in its
9 *Order Granting Joint Motion to Postpone Issuance of the Final Phase II HSR for the*
10 *Navajo Nation* (“Order”)². In its Order, the Court stayed the deadline for issuing the final
11 HSR for the Navajo Nation’s Phase II claims and ordered that ADWR “shall not issue the
12 final HSR for the Navajo Nation’s Phase II claims until further order by the Court” and
13 instead “shall issue a notice regarding this Order to all recipients of the notice filed on
14 March 28, 2024, pursuant to Arizona Revised Statute § 45-256(H).”

15 Pursuant to the Court’s Order, ADWR has provided notice of that Order to all
16 recipients of the notice filed on March 28, 2024 in the form of a mailer, as provided in
17 Attachment A to this Notice. This notice is being filed with the clerk of the court and
18 copies are being provided to persons included on the Court-Approved Mailing List for CV
19 6417. A copy of this Notice is also being posted to ADWR’s website at:



ARIZONA DEPARTMENT OF WATER RESOURCES NOTICE OF STAY

On March 28, 2024 the Arizona Department of Water Resources (“ADWR”) filed a 120-day notice of its intent to file the final hydrographic survey report (“HSR”) for cultural, tribal, recreational, fish, wildlife, conservation, mining, heavy industrial, commercial, and irrigation water uses on the portion of the Navajo Reservation within the Little Colorado River watershed.

However, on June 24, 2024 the Navajo Nation, United States, Hopi Tribe, San Juan Southern Paiute Tribe, Little Colorado River Coalition, Salt River Project Agricultural Improvement and Power District, Arizona State Land Department, City of Flagstaff, Atkinson Trading company, and Arizona Public Service Company jointly filed a motion asking the Court to postpone the issuance of the HSR. The Court granted the motion by order dated June 26, 2024.

In the order, the Court suspended the issuance of the HSR until further order of the Court and requested that ADWR issue this notice notifying recipients that the HSR will not be published on July 25, 2024.

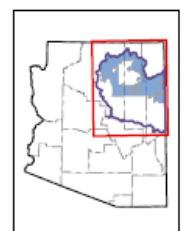
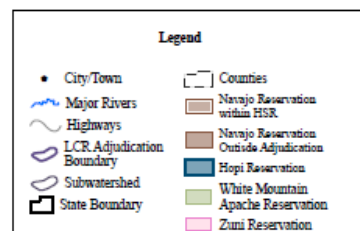
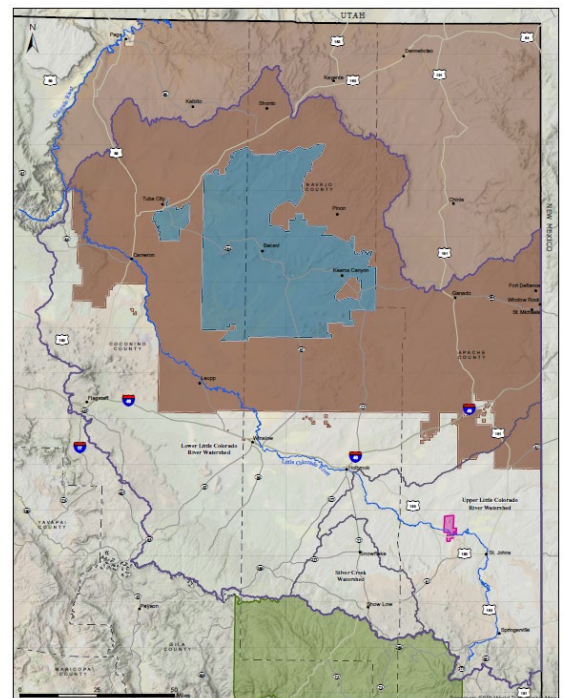
